Photo shoots*, groups of up to 6 people

Film and video shoots*, groups of up to 6 people

CHF 405.-	lump sum surcharge per hour outside office hours
CHF 100.-	lump sum payment for electricity consumption

For operational reasons, extensive Film or Advertising Shoots in the non – public areas shall not be granted

Photo shoots for groups of 7 to 50 people, can only be granted as an exception

(in the period from 8 a.m. to 5 p.m.)

CHF 400.-	for the first hour (basic fee)
CHF 250.-	for each additional hour
CHF 400.-	lump sum surcharge per hour outside office hours
CHF 50.-	lump sum payment for electricity consumption

Film and video shoots* for groups of 7 to 50 people, including extras, can only be granted as an exception

(in the period from 8 a.m. to 5 p.m.)

CHF 3250.-	for the first hour (basic fee)
CHF 1400.-	for each additional hour
CHF 3250.-	lump sum surcharge per hour outside office hours
CHF 100.-	lump sum payment for electricity consumption

* **Charges** apply to film and photo shoots in all areas of Zurich Airport that are carried out for commercial (including cinema and TV films) or advertising purposes. They also apply to shoots for use in corporate image brochures and annual reports. No discounts can be granted. **Charges do not apply** to shoots that are intended to provide the general public with **current information**.

All additionally required services such as provision of special electrical installations (hours worked by electrician), scaffolding, barriers, cleaning services, parking, dressing rooms, etc., are charged on the basis of the utilised materials and required working hours.

- Permits will not be granted for film and photo shoots at night or on weekends.
- Flughafen Zürich AG must be clearly recognisable in film footage and photos. The use of other airport logos is strictly prohibited, and the infrastructure may in no way be distorted or modified.
- All participants must wear an official badge whenever they are in non-public areas of the airport.
- Purchase of duty-free and tax-free goods is not permitted.

Care must be taken to avoid any form of interference with flight operations and passenger flows. All participants must always obey the instructions of accompanying airport personnel and employees of Terminal Management. If a scheduled shoot should clash with another event or other occurrences of a special nature, it may be cancelled at short notice. Flughafen Zürich AG shall be entitled to withdraw permission for a shoot, without an obligation to pay compensation, if the session has to be cancelled due to security considerations.

In the event that the applicant should cancel the shoot after the site inspection has taken place, Flughafen Zürich AG reserves the right to bill the applicant for the budgeted time.

By granting permission for a film or photo shoot, Flughafen Zürich AG shall not be held liable in any way whatsoever for accidents, damages or theft caused or incurred by the applicant. In other words, persons entering any areas of the Airport that are not accessible to the general public do so at their own risk.
