

# FOR YOUR OWN SAFETY

## ITEMS THAT ARE PROHIBITED (HAND BAGGAGE AND CHECKED BAGGAGE)



## RESTRICTED ITEMS



Liquids, gels, creams, pastes and sprays are allowed in hand baggage only in containers that do not exceed 100 ml (see overleaf for details). Larger quantities must be transported in checked baggage.



Sharp objects may be carried in hand baggage, provided the blade length does not exceed 6 cm. Objects with a blade length of over 6 cm must be transported in checked baggage.



Power banks may only be carried in hand baggage, and their output may not exceed 160 Wh. Power banks with a larger output are not permitted (see overleaf for details).



Spare batteries may only be carried in hand baggage, and their output may not exceed 160 Wh. Spare batteries with a larger output are not permitted (see overleaf for details).



Each passenger may carry one lighter or one box of matches on their person. Lighters and matches may not be carried in hand baggage or checked baggage.



Cartridges for self-inflating rescue devices must be secured against unintentional triggering and must be transported with the relevant devices.



E-cigarettes may only be carried in hand baggage.

## LIQUIDS

**Liquids in hand baggage are subject to special regulations:**

- Liquids, gels, creams, pastes and sprays are only permitted in hand baggage in containers with a maximum size of 100 ml.
- All containers (tubes, jars, bottles, etc.) must fit easily into a transparent, re-sealable plastic bag with a maximum size of one litre.
- One plastic bag is allowed per person (also applies to children and infants).
- Liquid medicines, baby food and food for special dietary requirements in the quantities necessary for the journey are also permitted in containers of over 100 ml.
- You may also take on board liquid tax & duty free articles in containers of over 100 ml, provided these are transported with the sales receipt in a sealed security bag (as per ICAO standards).

Liquids must be shown separately at the security checkpoint. They may only be taken on board the flight if they have been approved by the security staff.

## SPARE BATTERIES AND POWER BANKS

**For security reasons you may not take any spare batteries or power banks in your checked baggage. You may take such objects with max. output of 160 Wh in your hand baggage, subject to the following provisions:**

- Max. two spare batteries/power banks, if the nominal output of the individual products exceeds 100 Wh.
- The batteries/power banks must be secured individually against short circuits.
- Batteries and power banks with an output of over 160 Wh are prohibited.

## FIREARMS AND SHARP WEAPONS, AMMUNITION, SOPORIFIC/STUNNING DEVICES AND EXPLOSIVES

- Firearms, pointed weapons and ammunition may not be carried in hand baggage. These include airsoft weapons, imitation firearms and toy weapons.
- Carrying weapons in checked baggage requires a permit. Prior to transport, authorised personnel at the airport must also verify that the weapons are not loaded.
- Soporific/stunning devices (e.g. tear gas spray/taser guns) and all explosives are prohibited in baggage.
- Sharp objects (e.g. knives and scissors) with a blade length of under 6 cm are permitted in hand baggage. However, since some airports have stricter rules, we recommend you transport such goods in checked luggage.
